
RR- 267459-1, RR- 267459-2, RR- 267459-3, RR- 267459-4 and RR- 267459-5.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$95,811 within the Airports Enterprise Fund (41100) from the Unallocated Reserve Program (72081) to the Brown Field Capital Improvements Program (72035) for the Brown Field Industrial Park Redevelopment Project, (CIP No. 39-100).

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$95,811 from Airports Enterprise Fund (41100), (Brown Field Industrial Park Redevelopment Project, CIP No. 39-100) is hereby authorized, solely and exclusively for the purpose of providing funds for the above project and further authorizing the

City Auditor and Comptroller to transfer unexpended funds and credit any reimbursements to the appropriate reserves upon the advice of the administering department.
