WHEREAS, the Nejedly-Z'berg-Dills Solid Waste Management and Resource Recovery Act of 1972, hereinafter referred to as the "Act," requires each county, in cooperation with affected local jurisdictions, to prepare a comprehensive, coordinated Solid Waste Management Plan; and

WHEREAS, said Act also requires that such plan shall be consistent with state policy and any appropriate regional or sub-regional Solid Waste Management Plan; and


WHEREAS, the County of San Diego has prepared the 1986 revision of the San Diego Regional Solid Waste Management Plan in conformance with the Act and has submitted this revision of the Plan to the cities in the region for approval; NOW, THEREFORE,

1. That the above recitations are true and correct;
2. That the 1986 revision of the San Diego Regional Solid Waste Management Plan is hereby approved;
3. That the objectives set forth in the revision, the method and organization for implementation of the programs contained in the revision, the general procedure for financing the recommended programs, and the general role identified in the revision for the

County in implementing the revised Plan in an economical and environmentally acceptable manner are hereby approved.
