WHEREAS, the Planning Commission of The City of San Diego held a public hearing on May 15, 1986, to consider the proposed Tecolote Canyon Hillside Review Expansion Program; and

WHEREAS, as part of the Tecolote Canyon Hillside Review Expansion Program, the Planning commission approved an amendment to the LINDA VISTA COMMUNITY PLAN which would replace existing Tecolote Canyon rim development guidelines with language referencing the Tecolote Canyon Park Master Plan and the Hillside Review Overlay Zone ordinance as the appropriate documents outlining Tecolote Canyon rim development guidelines; and

WHEREAS, the Council of The City of San Diego held a public hearing to consider the Tecolote Canyon Hillside Review Expansion Program; and

WHEREAS, as part of the Tecolote Canyon Hillside Review Expansion Program, the Council of The City of San Diego considered the proposed amendment to the LINDA VISTA COMMUNITY PLAN; and

WHEREAS, the Council of The City of San Diego, by majority vote, approved the Tecolote Canyon Hillside Review Expansion Program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That this Council hereby approves the amendment to the LINDA VISTA COMMUNITY PLAN, a copy of which is on file in the office of the City Clerk as Document No. RR- 267475.

2. That this amendment shall become effective upon the date of its adoption.
