WHEREAS, the vacation of the City's interest in unneeded water and drain easements affecting Parcel 2 of Parcel Map 11645, as more particularly shown on Drawing No. 23308-1-D attached hereto as Exhibit "A", has been requested by the affected property owner; and

WHEREAS, the owner wishes to clear title to his land of all unnecessary easements in order to permit better utilization of the property; and

WHEREAS, the water and drain easements are being relocated and, therefore, the above-described easements are surplus to City needs; and


WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That pursuant to Section 8300 et seq. of the Streets and Highways Code the water and drain easements, as more particularly shown on the drawing attached hereto, are hereby vacated.

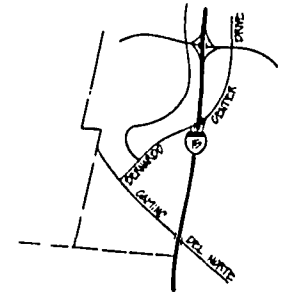
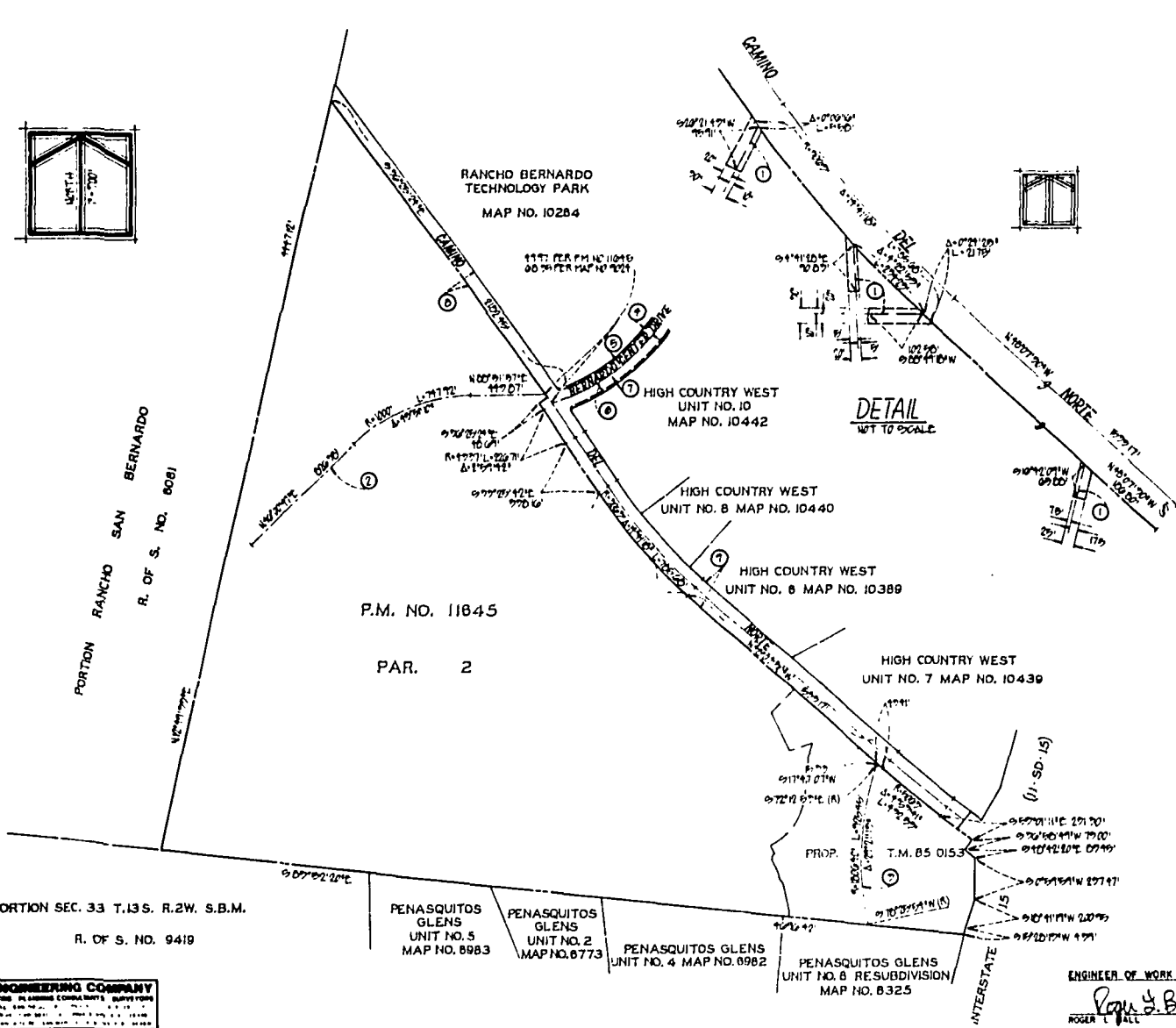

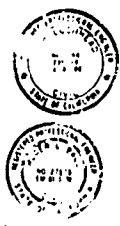
