RESOLUTION NUMBER R- 267502

ADOPTED ON JAN 20 1987

WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access in and to Camino Santa Fe north of Miramar Road adjacent and contiguous to a portion of the Northwest Quarter of the Southwest Quarter, and a portion of Lot 4, in Section 11, Township 15 South, Range 3 West; and

WHEREAS, the Engineering and Development Department has requested that the City revest these abutter's rights of access in the property to EGP - PID, INC., a California corporation, to allow better utilization of the land; and

WHEREAS, said abutter's rights of access are no longer needed by the City and should be revested in the property; and

WHEREAS, it has been determined that all affected City departments have no objection to the revestment of said abutter's rights; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and

WHEREAS, the City Manager recommends that said access rights be revested in the property; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf

of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 267502, quitclaiming to EGP - PID, INC., a California corporation, effecting the revestment of those abutter's rights of access in and to Camino Santa Fe north of Miramar Road adjacent and contiguous to a portion of the Northwest Quarter of the Southwest Quarter and a portion of Lot 4 in Section 11, Township 15 South, Range 3 West, as more particularly described in said deed.

2. That the City Clerk is hereby authorized and directed to deliver the quitclaim deed, and a certified copy of this resolution, attested by him under seal, to the Engineering and Development Department for further handling.
