WHEREAS, it has been determined that all affected City departments have no objection to the revestment of said abutter's rights; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and

WHEREAS, the City Manager recommends that said access rights be revested in the property; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf

of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 267502 quitclaiming to EGP - PID, INC., a California corporation, effecting the revestment of those abutter's rights of access in and to Camino Santa Fe north of Miramar Road adjacent and contiguous to a portion of the Northwest Quarter of the Southwest Quarter and a portion of Lot 4 in Section 11, Township 15 South, Range 3 West, as more particularly described in said deed.

That the City Clerk is hereby authorized and directed to deliver the quitclaim deed, and a certified copy of this resolution, attested by him under seal, to the Engineering and Development Department for further handling.
