RESOLUTION NUMBER R- 267539

WHEREAS, the San Diego Police Department's Mounted Unit owns a horse named Clyde O'Lark who suffers a degenerative bone disease affecting the front hooves which makes him unserviceable as a working animal and virtually unsalable, and

WHEREAS, the San Diego Police Department is spending approximately two-hundred dollars (\$200.00) each month on the care and upkeep of the horse named Clyde O'Lark without any return in services, and

WHEREAS, members of the San Diego Police Department's Mounted Unit have contacted veterinarians, trainers and farriers in search of a responsible person or organization willing to accept and care for the horse named Clyde O'Lark and keep him in a non-working status as long as his present condition persists; and

WHEREAS, Karen Ketelsen and Vahn Ketelsen of Alpine, California were made aware of Clyde O'Lark's condition and are willing to provide him with needed medical treatment, care for him in a non-working status as long as his present condition persists and purchase him as is without any warranties, express or implied, for the sum of one dollar (\$1.00); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement and Bill of

Sale for the sale of the horse known as Clyde O'Lark, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR. 267539
