

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of CENTER CITY FORD is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of POLICE PATROL CARS, 143 each (1987 Ford LTD Crown Victoria with 302-V8, 49 state engine) at a cost of \$10,495.55 each and 25 each (1987 Ford LTD Crown Victoria with 302-V8, 49 state engine and power windows) at a cost of \$10,717.55 each for a total combined cost of \$1,768,802.40; terms \$300 discount per unit if paid within 21 days, plus sales tax, less trade-in allowance as follows:
