

RESOLUTION No. R-267555 (R-87-1410)

Adopted on JAN 26 1987


BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of SIMPSON'S LANDSCAPING for BRUSH, WEED, AND DEBRIS REMOVAL (AREA A) from undeveloped City Property on slopes along canyon rims (Bid No. 7645) is hereby rejected.
2. That the low bid of PEDERSEN TREE SERVICE is hereby accepted and the City Manager is hereby authorized to execute a contract for BRUSH, WEED, AND DEBRIS REMOVAL (AREA B) 51% of the total area of Area B from undeveloped City Property on slopes along canyon rims (Bid No. 7648) as may be required for a period of seven (7) months beginning February 1, 1987 through August 31, 1987 or until the job is completed, whichever is later, at a cost of \$5,010.00 per acre for a total estimated cost of \$186,522.30; terms 1/2% 20 days; with an option to renew for an additional one (1) year period with a price escalation not to exceed 15% of bid price.
3. That the low bid of PEDERSEN TREE SERVICE is hereby accepted and the City Manager is hereby authorized to execute a contract for BRUSH, WEED, AND DEBRIS REMOVAL (AREA C) 51% of the total area of Area C from undeveloped City Property on slopes along canyon rims (Bid No. 7647) as may be required for a period of seven (7) months beginning February 1, 1987 through August 31, 1987 or until the job is completed, whichever is later, at a cost of \$5,880.60 per acre for a total estimated cost of \$413,876.62; terms 1/2% 20 days, with an option to renew for an additional one (1) year period with a price escalation not to exceed 15% of bid price.
4. That the low bid of PEDERSEN TREE SERVICE is hereby accepted and the City Manager is hereby authorized to execute a contract for BRUSH, WEED, AND DEBRIS REMOVAL (AREA D) 51% of the total area of Area D from undeveloped City Property on slopes along canyon rims (Bid No. 7646) as may be required for a period of seven (7) months beginning February 1, 1987 through August 31, 1987 or until the job is completed, whichever is later, at a cost of \$6,751.80 per acre for a total estimated cost of \$451,087.75; terms 1/2% 20 days, with an option to renew for an additional one (1) year period with a price escalation not to exceed 15% of bid price.

5. That the low bid of PEDERSEN TREE SERVICE is hereby accepted and the City Manager is hereby authorized to execute a contract for BRUSH, WEED, AND DEBRIS REMOVAL (AREA E) 51% of the total area of Area E from undeveloped City Property on slopes along canyon rims (Bid No. 7649) as may be required for a period of seven (7) months beginning February 1, 1987 through August 31, 1987 or until the job is completed, whichever is later, at a cost of \$5,010.00 per acre for a total estimated cost of \$431,811.90; terms 1/2% 20 days, with an option to renew for an additional one year period with a price escalation not to exceed 15% of bid price.
