Fred Hoyle	Police	\$5,000.00	Mr. Hoyle is a Sergeant in the Administrative Section of the Central Division. He suggested assigning two line officers per round to the pistol range. Actual savings of \$48,830.80 in time has been realized. This is his full award.
Duane Zimmerman Wesley Williams	Utilities	\$5,000.00	Mr. Zimmerman is a Waste Water Plant Lead Operator and Mr. Williams is a Waste Water Plant Operator in the Metro Division. They suggested modifying the scumming system. Actual savings of \$21,455.38 in time has been realized. This is their full award.
Sean Donovan	Police	\$1,587.60	Mr. Donovan was a Police Agent at the time of this suggestion. He suggested reducing lot size of firearms disposed of by Police auctions. Actual savings of \$5,292.00 in increased revenue was realized. This is his full award.
Anthony Bettinelli	Engineering & Development	\$1,000.00	Mr. Bettinelli is a Project Officer II in the Transportation Design Division. He suggested accelerating Federal reimbursements of City funds expended on FAU and FBRR projects. Actual savings of \$42,430.64 in interest earned. This is his full award.
