Bradley Snyder	Engineering & Development	\$ 320.00	Mr. Snyder is a Senior Drafting Aide in the Mapping Division. He suggested computerizing inventory catalogues of City storerooms. Although savings are difficult to identify, this is considered to be a significant operational improvement.
Marla Brubaker	Citizens Assistance	\$ 124.31	Ms. Brubaker is a Senior Typist. She suggested using monthly parking permits instead of hourly stamps for pool personnel. Actual savings of \$414.36 in savings earned.
Charles Hogquist	Police	\$ 80.00	Mr. Hogquist is a Police Officer II in the Southeastern Division. He suggested listing phone numbers in white pages for area Police Stations. Although savings are difficult to identify, this is considered to be a significant operational improvement.
Michael Donnelly	Fire	\$ 45.00	Mr. Donnelly is a Fire Engineer. He suggested pressure testing the intake gate valves upon receipt and annually. Although savings are difficult to identify, this is considered to be a significant operational improvement.
