ADOPTED ON FEB 2 1987

BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF SIDEWALK AND CURB REPLACEMENT ON VARIOUS CITY STREETS, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on FEB 2 1987, and bearing official Document No. RR-267581, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF SIDEWALK AND CURB REPLACEMENT ON VARIOUS CITY STREETS.

BE IT FURTHER RESOLVED, that the City Manager and the City Auditor and Comptroller are directed and they are hereby authorized to add CIP No. 52-348 SIDEWALK, CURB AND GUTTER REPLACEMENT as a CIP project to the Fiscal Year 1987 Capital Improvements Program.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$100,000 from CIP No. 52-342 ANNUAL ALLOCATION - 50/50 SIDEWALK REPLACEMENT to CIP No. 52-348 SIDEWALK, CURB AND GUTTER REPLACEMENT.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$100,000 from Capital Outlay Fund 30245, CIP No. 52-348 SIDEWALK, CURB AND GUTTER REPLACEMENT is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
