

RESOLUTION NUMBER R- 267590

APPROVING MAP OF CANYON COUNTRY UNIT NO. 5.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Reginald Dale Harvey, Jr., Licensed Land Surveyor, entitled "CANYON COUNTRY UNIT NO. 5 being a subdivision of a portion of Parcels 2 and 4 of Parcel Map No. 12882 together with a portion of Parcel 3 of Parcel Map No. 13065, according to maps thereof on file in the office of the County Recorder of San Diego County, all in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Acama Street, and a portion of Calle Cristobal, and said street(s) and portion(s) of street(s) are hereby declared to be public street(s) and portion(s) of public street(s) and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of access in and to Calle Cristobal, adjacent and contiguous to Lot 5; and in and to Acama Street, adjacent and contiguous to Lots 1 and 3, all as shown on the map within the subdivision.

That said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the building restricted easement(s) over, upon or across Lot 4, as granted and shown on said map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, the easement(s) listed in paragraphs 2 and 3 of the Owner's Certificate as shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street(s) and portion(s) of street(s) are accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, the building restricted easement(s), and the easements listed in paragraphs 2 and 3 of the Owner's Certificate, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
