Butcher, Licensed Land Surveyor, entitled "SCRIPPS WESTVIEW II being a subdivision of Parcels 3 and 4 of Parcel Map No. 12685, filed in the office of the County Recorder of San Diego County, April 29, 1983, in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.



That said Council hereby accepts on behalf of The City of San Diego, the building restricted and open space easement(s) over, upon or across Lots 1 and 2, excepting those portions of Lots 1 and 2 covered by Building Sites A-1 through A-11, B-1, and C-1 through C-11, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map; the easement(s) with the right of ingress and egress for the construction and maintenance of general utility facilities, as well as the building restricted easement(s), all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
