BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Third Amendment to the Contract with Ferver Engineering Company, for the structural plan check of the proposed San Diego Convention Center, under the terms and conditions set forth in the Third Amendment to the Contract on file in the office of the City Clerk as Document No. RR- 267609.


BE IT FURTHER RESOLVED, that the Third Amendment to the Contract is hereby increased by an amount not to exceed \$36,000.00 for a total contract of \$162,516.79, extending the Third Amendment to the Contract to May 19, 1989, to allow for plan checking of revisions during construction and to revise the rate of payment for checking.

BE IT FURTHER RESOLVED, that the Building Inspection Department is hereby authorized to expend an amount not to exceed \$29,000.00 on Fire/Life/Safety plan check of the San Diego Convention Center.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to refund to the San Diego Unified Port District any unexpended portion of the \$191,516.79 which the San Diego Unified Port District has paid to The City of San Diego for plan check services, upon completion of the construction.
