

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. DENARDI TRUCK EQUIPMENT, 2. SERVICE MANUFAC-TURING CO., 3. TERRA EXCAVATION & TRAILER SALES, and 4. ROYAL TRUCK BODIES INC. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of VARIOUS TRUCK BODIES as follows:

- $\frac{\text{DENARDI TRUCK EQUIPMENT}}{\text{Cross Bed Tool Boxes at a cost of $127.86 each,} \quad \text{for a total}$ cost of \$4,475.10; Item 4 - eight (8) each 1½ cu. yard Dump Bodies at a cost of \$3,080.00 each, for a total cost of \$24,640.00; Item 7 - one (1) each 9 Ft. Flatbed Body for a cost of \$1,32 $\overline{8.00}$; Item 8 - one (1) each 10 Ft. Flatbed Body with hoist for a cost of \$2,513.00; Item 9 - two (2) each 12 Ft. Flatbed Bodies at a cost of \$811.00 each, for a total cost of \$1,622.00; Item 10 - one (1) 14 Ft. Flatbed with hoist at a cost of \$2,631.00; and Item 11 - two (2) each 14 Ft. Flatbed Bodies at a cost of \$1,404.00 each for a total cost of \$2,808.00; for a combined total cost of \$40,017.10; terms 1% 30 days, plus sales tax.
- 2. SERVICE MANUFACTURING CO. for Item 2 - four (4) each 56" Service Bodies at a cost of \$1,649.00 each for a total cost of \$6,596.00; and Item 3 - Five (5) each 60" Service Bodies at a cost of $$1,65\overline{3.00}$ each for a total cost of \$8.265.00; for a combined total cost of \$14,861.00; terms net 30 days, plus sales tax.
- TERRA EXCAVATION & TRAILER SALES for Item 5 one Dump Body, 3. 5 cu. yard, installed, at a cost of \$5,562.77; terms 2% 30 days, plus sales tax.
- 4. ROYAL TRUCK BODIES INC. for Item 6 - one (1) each Engineer Body at a cost of \$5,612.00; terms net 30 days, plus sales tax.
