
RESOLUTION NUMBER R- 267645

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Second Amendment to the agreement with NASLAND ENGINEERING, INC., for development of the First San Diego River Improvement Project (FSDRIP), amending the Agreement on file in the office of the City Clerk as Document No. RR-265860, under the terms and conditions set forth in a second amendment to agreement on file in the office of the City Clerk as Document No. RR-267645.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$35,000 (\$25,000 from the Sewer Revenue Fund (41506), North Mission Valley Interceptor Sewer (NMVIS), CIP No. 43-033 ; and \$10,000 from FSDRIP, Fund 79360), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
