RESOLUTION NUMBER R-267650 ADOPTED ON FEBRUARY 9, 1987

WHEREAS, on December 17, 1986, the Public Services and Safety Committee approved a motion recommending that the Council authorize the expenditure of \$100,000 for a contribution to the "Sail America Foundation;" and

WHEREAS, the Foundation is administering the sailing craft "Stars and Stripes" in the America's Cup competition off the coast of Western Australia; and

WHEREAS, the PS&S Committee recommended that the City's contribution be funded by the Transient Occupancy Tax (T.O.T.) to the extent available, with the General Fund Unallocated Reserve to pay the remainder, even if 100%, due to insufficient T.O.T. revenues; and

WHEREAS, the Committee further recommended that Council direct that T.O.T. funds reimburse the General Fund Unallocated Reserve, as revenues may allow in the future but the City Manager projects no surplus T.O.T. funds will be available in FY 1987; and

WHEREAS, in City Manager Report No. 86-598, the City Manager had recommended against contributing any General Fund monies to the Foundation to fund operating expenses, and recommended that any economic analysis, if desired, be conducted and funded by other interested parties, not the City, but the PS&S Committee took no action concerning the economic impact analysis addressed; and

WHEREAS, an alternative proposal was submitted by the originator in respect to the source and amount of funds to be granted; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller be and he is hereby authorized and directed to pay to the "Sail America Foundation" the sum of \$50,000 from the Cruise Ship Consortium, Fund 10223, Department 915, Organization 502, for the purpose of defraying expenses incurred by the "Stars and Stripes" challenge in the 1986-87 America's Cup competition.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby further authorized and directed to pay over to the "Sail America Foundation" from the Cruise Ship Consortium at the close of fiscal year 1987, a sum not to exceed \$50,000, for the sole and exclusive purpose of future promotion of the America's Cup defense.
