BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That said Council hereby finds that certain map surveyed by Walter F. Butcher, Jr., Registered Civil Engineer, entitled "CARMEL MOUNTAIN RANCH UNIT 13 being a subdivision of a portion of Lots 12, 14, 15, 23 and 26 of Pompeii Farm Co., Pompeii Subdivision, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 1738, filed in the office of the County Recorder of San Diego County, September 19, 1922, together with those portions of Pompeii Boulevard and 2nd Street adjoining said lots as vacated and closed to public use, approval of said map revoked per City Council Resolution No. 203023, adopted October 12, 1971," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
