WHEREAS, a celebration to welcome the victorious Stars and Stripes crew and supporters back to our fair City will be conducted; NOW, THEREFORE,



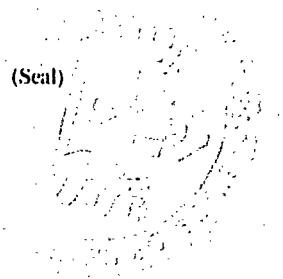
