- 2. That the City Manager is hereby authorized to execute a contract with the lowest responsive and reliable bidder to furnish one (1) supervisor's sedan, three (3) mini-vans, audio visual training equipment.
- 3. That the City Manager is hereby authorized to contract for purchase of one (1) supervisor's sedan, three (3) mini-vans, audio visual training equipment.

4. That the expenditure, not to exceed \$86,000 from Fund 10132, is hereby authorized solely and exclusively for the purchase of one (1) supervisor's sedan, three (3) mini-vans, audio visual training equipment and supplies, office supplies, and related costs.
