
RESOLUTION NUMBER R- 267709

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the State of California (CALTRANS), for the design and construction of a traffic signal at the intersection of the northbound I-5 on/off ramps and Palm Avenue, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 267709 .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$41,000 from Capital Outlay Fund 30245, CIP No. 68-001, "Cooperative Signal Projects," is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
