BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$100,000 made payable to the LOS PENASQUITOS LAGOON FUND, with

the approval of the Regional Water Quality Control Board's Executive Officer, for Los Penasquitos Lagoon enhancement or mitigation purposes.
