WHEREAS, the Mayor and City Council have expressed a strong interest in ensuring that The City of San Diego is doing everything possible to maximize the effectiveness of its fight against drug abuse; and

WHEREAS, to further strengthen the effort, a Committee

Against Drug Abuse will be formed comprised of knowledgeable

citizens assigned to examine all facets of the drug problem in

San Diego and to prepare a plan of action for City government

that will support the effort to reduce drug abuse; and

WHEREAS, the members representing several categories of community, political and staff expertise, are set forth in Attachment "A" hereto; and

WHEREAS, the concept of duties, composition and Committee activity is set forth in the October 16, 1986 report to the City Manager from the Chief of Police, a copy attached hereto as Attachment "B"; and

WHEREAS, said Committee is appointed pursuant to section 43(b) of the City Charter and assigned the task set forth hereinabove; and

WHEREAS, the Committee will be assisted by a trained and capable consultant who will provide major staff support; and

WHEREAS, it is now necessary and appropriate to authorize the creation of the Committee; and

WHEREAS, it is further necessary to direct the City Manager to advertise, as quickly as possible and as may be necessary and required, for a professional consultant for support to the Committee, with the selected consultant entering upon and eighteen-month agreement with the City, assuming funding is provided by Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That pursuant to section 43(b) of the Charter of The City of San Diego, there is hereby established a Committee Against Drug Abuse to consist of those categories and named individuals as reflected on the roster attached hereto as Attachment "A" with duties and activities as set forth conceptually in the proposal of the Chief of Police to the City Manager, dated October 16, 1986, and attached hereto as Attachment "B".
- 2. That the City Manager be and he is hereby directed to advertise within a three- to four-week timeframe, for a professional consultant to provide support services to the Committee, with the person selected to execute an eighteen-month agreement with the City, assuming funding for said period of service is approved by Council.
- 3. That the City Manager is directed to return to Council with his recommendation for a consultant and an agreement incorporating the necessary and required services for the eighteen-month period.
- 4. That the Auditor and Comptroller be and he is hereby authorized to transfer, at this time, the sum of \$100,000 within

the General Fund 100 from the Police Department 11000, Program Element 11010 to Non-Departmental Expense, Committee on Drug Abuse [Department 601, Program Element 60109] for the purpose of consultant expense support and miscellaneous expenses that may be incurred.

SUBJECT: proposal for a "Mavor's Commission Against Drug Abuse"

1. PURPOSE AND INTENT

A Mayor's Commission Against Drug Abuse should be established to study, consult and advise the Mayor, City Council, and City Manager on drug abuse. in the City of San Diego and prevention efforts which could be taken by the City to reduce substance abuse by its citizens. The commission should study the scope of the problem, develop specific recommendations and provide a program to monitor the City's progress toward a drug free San Diego.

2. METHODOLOGY

A. . . COMPOSITION OF COMMISSION

All members of the commission should be chosen and appointed by the mayor. The size of the membership should be decided upon by the mayor after first determining the level and amount of input desired and the optimal number of members that might work together effectively. The Police Department recommends that certain community members be considered for appointment as per the attached list. In addition, the mavor may wish to consider requesting nominations for membership from each council district.

The mayor should appoint the commission chair or serve in that position herself. Also, consideration should be given to the creation of subcommittees to study specific areas of concern.

\$100,000.00 has been budgeted to provide staff support to the commission, including analysts and clericals, which will be transferred to and paid out of the City Manager's Budget. The City Manager's Office and the Police Department will provide liaison personnel to assist the commission in accomplishing its task.

B. COMMISSION FACT FINDING

It is recommended that a series of meetings be held to inform the commission as to the nature and extent of drug problems in San Diego as well as existing prevention and rehabilitation efforts.

These meetings should include:

- 1. Briefings by law enforcement officials and representatives of the Probation Department, State Parcle and the Judiciary.
- Presentations by professionals and medical experts in the fields of drug abuse prevention, treatment and rehabilitation.

C. COMMUNITY HEARINGS

Community hearings should be held throughout the City of San Diego to solicit the public's assessment of drug abuse and related problems in their area. These hearings could be modeled after those conducted by the Citizen's Advisory Board on Police/Community Relations.

D. SURVEY INFORMATION AND PROGRAM REVIEW

The staff analyst should conduct a survey of the related literature and provide a cogent summary to the commission. The staff analyst would also be available to organize and report upon the data gathered at briefings, meetings, hearings. There may be sufficient funds in the allocated budget to allow for a LIMITED community survey on selected topics. The staff analyst should also assist the commission in developing an appropriate review mechanism to determine their effectiveness.

3. RECOMMENDATIONS

The commission, based upon the information received and developed, should assess the scope of the drug abuse problem in San Diego and make recommendations to the City Council regarding appropriate remedial and prevention strategies.
