

RESOLUTION NUMBER R- 267753

ADOPTED ON FEB 23 1987

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Resolution No. 258048, adopted March 1, 1983, declaring the subdivider of DEL CERRO HEIGHTS UNIT NO. 2 to be in default be, and it is hereby rescinded.

2. That the City Attorney be, and he is hereby authorized to execute a Settlement and Release Agreement and file a dismissal in Superior Court Case No. 500601, City of San Diego v. Surety Co. of the Pacific.

3. That the City Manager be, and he is hereby authorized to accept a check in the sum of \$21,000.00 to be deposited in Trust Account No. 9022, Fund No. 63021, for the purpose of completing the subdivision work and closing subdivision accounts, and for doing any work in connection with traffic safety within the neighborhood except for the widening of Camino Rico.

4. That the City Engineer be, and he is hereby authorized to set the deferred lot stakes and monuments either by the use of City forces or contract with a private engineer or land surveyor using the cash surety in the sum of \$2,200.00 from Trust Account No. 9022, Fund No. 63021.

5. That the City Manager be, and he is hereby authorized to accept the subdivision, record a "Notice of Completion and Acceptance," and release Performance Bond No. 107075 in the sum of \$205,156.00 issued by Surety Company of the Pacific.
