BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to initiate proceedings for the formation of a landscape maintenance district pursuant to the Landscape and Lighting Act of 1972 (Sections 22,500, et seq., Streets and Highways Code) and the San Diego Maintenance District Procedural Ordinance of 1975 (Sections 65.0201, et seq., San Diego Municipal Code), said district shall be known and designated as the "GATEWAY CENTER EAST LANDSCAPE MAINTENANCE DISTRICT."

BE IT FURTHER RESOLVED, that the City Engineer is hereby directed to prepare and file a report in accordance with Chapter 1, Article 4 of said Act.
