

RESOLUTION NUMBER R- 267760
ADOPTED ON FEB 23 1987


BE IT RESOLVED, by the Council of The City of San Diego, that the City Council hereby approves in concept the City Manager's recommendations as contained in City Manager Report No. 87-51, dated January 23, 1987, relating to the proposed future disposition of the approximately 50.1 acres of land and the 42 buildings on the Balboa Park property being returned to park and recreation use in connection with the Naval Hospital redevelopment.

BE IT FURTHER RESOLVED, that the City Council hereby authorizes the retention of Building 1 (Administration), Building 8 (Library), and Building 149 (Chapel).

BE IT FURTHER RESOLVED, that the issues of the horse stables, reduced parking, formalized gardens, courtyards, and enhancement of landscaping around certain other buildings, as well as the question of the use of the Administration Building (Building 1), are hereby referred to the Public Facilities and Recreation Committee for further study.

BE IT FURTHER RESOLVED, that the City Manager is hereby directed to prepare additional reports refining the recommendations contained in the above Manager's report and to bring back proposals with regard to the implementation of said recommendations.
