WHEREAS, the Intergovernmental Relations Department (IRD) requested the various departments of the City, by memorandum dated September 9, 1986, to submit proposals for inclusion in The City of San Diego's 1987 Legislative Sponsorship Program; and

WHEREAS, the Council of The City of San Diego has previously reviewed and approved three proposals for inclusion in The City of San Diego's 1987 Legislative Sponsorship Program; and

WHEREAS, on February 4, 1987, the Rules Committee reviewed and approved eight additional proposals regarding removal of unattended vessels from public waterways, removal of lobster traps threatening public safety, inclusion of lifeguards and marine safety officers as emergency rescue personnel, clarification of markings for enforcement vessels, authorization of lifeguards and marine safety officers to close public areas in emergencies, assignment of expenses incurred in responding to false emergency reports, state enterprise zone small business loan funding and abandoned vehicle lien sales, as described in IRD Report No. 87-1, dated January 29, 1987; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the legislative proposals described in IRD Report No. 87-1, dated January 29, 1987, be and the same are hereby approved for

inclusion in The City of San Diego's 1987 Legislative Sponsorship
