

RESOLUTION NUMBER R- 267770

ADOPTED ON FEB 23 1987

WHEREAS, the MIRA MESA COMMUNITY PLAN is currently on a monitoring status; and

WHEREAS, the adequacy of the existing parks, circulation system and population estimates have been brought into question; and

WHEREAS, the validity of the community plan's land use concepts are in question due to the extraordinary number of plan amendments initiated by property owners which are pending within the community; and

WHEREAS, the City Council desires to shift the MIRA MESA COMMUNITY PLAN from the monitoring to active status (under the provisions of Council Policy 600-24); and

WHEREAS, the City Council desires to proceed with a comprehensive community plan update of the MIRA MESA COMMUNITY PLAN in order to resolve the issues that are currently in question within the community; and

WHEREAS, the City Council desires to proceed with all other budgeted community planning projects; and


WHEREAS, adequate salary savings within the current year Planning Department Budget are anticipated to offset the cost of a city planner in an over-budgeted status; and

WHEREAS, it is deemed necessary and appropriate for the City Council to act on this matter to expedite the resolution of issues currently in question in the community; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of said City, hereby directs that the MIRA MESA COMMUNITY PLAN be placed on active status, and that the Planning Department's Fiscal Year 1987 Work Program be amended to include the update of the MIRA MESA COMMUNITY PLAN with costs to be absorbed by anticipated Fiscal Year 1987 salary savings.
