BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a grant deed of THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO, a public body, corporate and politic, executed in favor of The City of San Diego, bearing date of June 23, 1986, a copy of which deed is on file in the Office of the City Clerk as Document No.

RR- 267776, granting to said City an easement for public street purposes in portions of Lots 27 through 31 in Block 1 of Broderick and West Addition, Map No. 1117, and in portions of Lots 25 through 28 in Block 1 of Orange Park, Map No. 1210, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named PICKWICK STREET.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
