BE IT RESOLVED, by the Council of The City of San Diego, that Friday, February 27, 1987 be and it is hereby declared to be "KAISER PERMANENTE DAY" in celebration of its 20th Anniversary in the San Diego area in providing quality health care to San Diego residents.
