BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an additional \$160,000 within the Sewer Revenue Fund 41506 from the Unallocated Reserve 70697

to the Wastewater Treatment Plant Construction Program 70292, CIP No. 46-119 ANNUAL ALLOCATION - POINT LOMA TREATMENT PLANT.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$160,000 from the Sewer Revenue Fund 41506, CIP No. 46-119 ANNUAL ALLOCATION - POINT LOMA TREATMENT PLANT to supplement funds previously authorized by Resolution No. 267006, adopted on November 10, 1986, is hereby authorized solely and exclusively for this project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
