

RESOLUTION NUMBER R- 267801

ADOPTED ON MAR 2 1987

WHEREAS, on October 28, 1986, the Council of The City of San Diego held a public hearing on the North City Sphere of Influence; and

WHEREAS, the City Council unanimously approved a sphere boundary to be recommended to the Local Agency Formation Commission that included portions of the unincorporated County of San Diego; and

WHEREAS, the City Council approved a motion requesting that the County enter into an agreement with the City regarding development in Subareas 2 and 3 of the North City Sphere of Influence study area as identified in Planning Report No. 86-603 on file in the office of the City Clerk as Document No. RR-266893 and

WHEREAS, representatives of the City and County have expressed a mutual interest in planning for a regional park and recreation facility in the San Dieguito River Valley; and

WHEREAS, the City Council has considered the GUIDELINES FOR ORDERLY DEVELOPMENT IN THE SAN DIEGUITO RIVER VALLEY; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the GUIDELINES FOR ORDERLY DEVELOPMENT IN THE SAN DIEGUITO RIVER VALLEY, on file in the office of the City Clerk as Document No. RP-267801 be, and they are hereby approved.

2. That the Planning Director and City Manager are directed to transmit a copy of the guidelines to the County Board of Supervisors for its consideration and approval.
