BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the addition of CIP No. 52-384, Mira Mesa Lighting and Landscaping and CIP No. 52-370, Linda Vista Road Landscaping to the FY 1987 Capital Improvement Program is hereby authorized.
- 2. That the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$382,255 into CIP No. 52-030.3, Meadowbrook Drive Blackstone Court to Jamacha Roads, consisting of \$200,000 from CIP No. 52-328, Friars Road Median Barriers, Gas Tax Fund 30219 and \$182,255 from CIP No. 52-328.2, Friars Road Median Barriers, Phase II, Gas Tax Fund 30219.
- 3. That the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$731,128 into CIP No. 52-384, Mira Mesa Lighting and Landscaping, consisting of \$191,128 from CIP No. 52-030.3, Meadowbrook Drive Blackstone Court to Jamacha Road, Capital Outlay Fund 30245 and \$540,000 from CIP No. 29-423.1, Winterwood Lane Community Park Recreation Building, Capital Outlay Fund 30245.
- 4. That the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$725,496 into CIP No. 52-370, Linda Vista Road Landscaping, consisting of \$191,127 from CIP No. 52-030.3, Meadowbrook Drive Blackstone Court to

Jamacha Road, Capital Outlay Fund 30245, \$334,000 from Community Development Block Grant Fund 18523, Department 5633, Org. No. 3309, and \$200,369 from Community Development Block Grant Fund, 18522, Department 5863, Org. No. 6306.
