

RESOLUTION NUMBER R- 267828
ADOPTED ON MAR 9 1987

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE PUBLIC STREETS, HIGHWAYS, AND SERVICE EASEMENTS VACATION LAW, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE CALIFORNIA STREET BETWEEN DR. MARTIN LUTHER KING, JR. WAY AND "G" STREET AND ADJACENT TO LOTS A-F BLOCK 31 AND LOTS G-L BLOCK 32, ALL WITHIN MAP 456, AND FIXING A TIME AND PLACE FOR THE PUBLIC HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the public interest and convenience of said City may require the vacation of California Street between Martin Luther King, Jr. Way and "G" Street and adjacent to Lots A-F Block 31 and Lots G-L Block 32, all within Map 456, hereinafter mentioned.

2. That it is the intention of said Council to order the vacation of California Street between Dr. Martin Luther King, Jr. Way and "G" Street, as more particularly shown on Drawing No. 16874-B, on file in the office of the City Clerk as Document No. RR-267828.


3. The Council hereby elects to proceed, in making said vacation, under the provisions of the "Public Streets, Highways, and Service Easements Vacation Law." California Streets and Highways Code Section 8330 et seq.

4. The Council hereby fixes 10:00 a.m. on the 7th day of April, 1987, in the Council Chambers on the twelfth floor of the City Administration Building, Charles C. Dail Concourse, 202 "C"

Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.

5. That The Daily Transcript, a daily newspaper published and circulated, and of general circulation, in the said City of San Diego, be, and it is hereby designated as the newspaper in which the Street Superintendent of said City shall cause to be published, in the manner and form required by law, notice of the passage of this Resolution of Intention, and the Street Superintendent is hereby directed to cause notices of the passage of this resolution to be posted in the manner and form required by law and to cause a notice similar in substance to be published in said newspaper in the manner required by law.
