
RESOLUTION NUMBER R- 267839

BE IT RESOLVED, by the Council of The City of San Diego, that the expenditure of an amount not to exceed \$53,820.00 from Federal Revenue Sharing Funds, CIP No. 37-028, Annual Allocation, Undergrounding of City Utilities as payment to San Diego Gas and Electric Company, is hereby authorized, solely and exclusively, for the purchase of nineteen (19) new street lights to replace existing pole-mounted street lights in the three (3) UNDERGROUND UTILITY DISTRICTS listed below.
