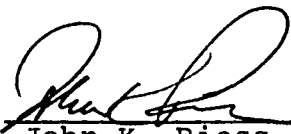

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$30,000 from CIP No. 52-281.0, "La Jolla Village Drive/Miramar Road," Fund No. 79001 to CIP No. 53-041.0, "La Jolla Village Drive Bridge Over I-5," Fund No. 79001.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$250,000 from CIP No. 53-041.0, "La Jolla Village Drive Bridge Over I-5," Fund No. 79001, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
