ADOPTED ON MAR 9 1987

WHEREAS, the Save Mission Beach Park Association filed with the City Clerk's office an initiative petition regarding commercial development on City-owned land; and

WHEREAS, the petition was properly filed and found to contain sufficient verified signatures of over ten (10) percent of the City's registered voters as required by the Charter for submission to the voters; and

WHEREAS, the Council under Municipal Code section 27.2521 must approve or reject the legislative act as presented by the above-referenced petition; and

WHEREAS, the Council under Municipal Code section 27.2522 must call a special election to be consolidated with the next City-wide election should the Council reject the above-referenced petition; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Council rejects the legislation contained in the above-referenced petition and directs the City Attorney to

prepare an ordinance calling a special election to be consolidated with the regularly scheduled election of November 3, 1987.
