RESOLUTION NUMBER R- 267851

ADOPTED ON MAR 10 1987

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on May 15, 1986, to consider proposed amendments to the Centre City/Pacific Highway Corridor Land Use Plan Segment of the City's Local Coastal Program; and

WHEREAS, said Centre City/Pacific Highway Corridor Land Use Plan was certified by the California Coastal Commission on May 23, 1983, subject to suggested modifications determined necessary to meet the requirements of the California Coastal Act; and

WHEREAS, the proposed amendments are intended to comply with the modifications suggested by the California Coastal Commission; and

WHEREAS, it is The City of San Diego's intention to obtain certification of the Centre City/Pacific Highway Corridor Land Use Plan by the California Coastal Commission; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego:


