RESOLUTION NUMBER R-267856

ADOPTED ON MARCH 10, 1987

WHEREAS, the City Manager is obligated under Ordinance No. O-16695 to order the cessation of building permits in the Pump Station No. 64 service area when there is any sewage spill from Pump Station No. 64 that causes environmental damage to the Los Penasquitos Lagoon; and

WHEREAS, such a spill occurred on March 5, 1987 and the Manager issued the cessation order as required; and

WHEREAS, Ordinance No. O-16695 requires the Council at the next regularly scheduled meeting after such an order to conduct a hearing to either approve or reject the Manager's action; and

WHEREAS, on March 10, 1987 the Council conducted a hearing on whether to approve or reject the Manager's action and heard testimony both on the cause and consequences of the spill; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council approves the Manager's action placing a moratorium on the issuance of building permits which require a sewer hookup in

the Pump Station No. 64 area within The City of San Diego and directs the City Manager to docket the matter again on April 21, 1987 at 10:00 a.m. for review.
