
RESOLUTION NUMBER R- 267860

BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. LONG BEACH IRON WORKS, INC. and 2. MARDEN SUSCO meeting specifications are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of 6 INCH WET BARREL FIRE HYDRANTS as may be required for a period of one (1) year beginning March 1, 1987 through February 29, 1988 as follows:

1. LONG BEACH IRON WORKS, INC. for Item 1, (2 way fire hydrants) at a cost of \$240.00 each, for a total estimated cost of \$24,000.00; terms 2% 30 days, plus applicable California sales tax, with option to renew contract for two (2) additional one (1) year periods, with no contract price escalation.
2. MARDEN SUSCO for Item 2, (3 way fire hydrants) at a cost of \$332.70 each, for a total estimated cost of \$23,289.00; terms 5% 20 days, plus applicable California sales tax, with an option to renew contract for two (2) additional one (1) year periods, subject to a maximum 20% price increase over the previous contract year.
