
RESOLUTION NUMBER R- 267915

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$34,400 from Job Training Partnership Act, Fund 18201, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project and related activities.
