She suggested increasing license fees to offset record check charges made by the State. Although savings are difficult to identify, this is considered to be a significant operational improvement.
David Doughty	Police	\$ 25.00	Mr. Doughty is a Storekeeper at the Western Division. He suggested transferring inventory of high-power batteries to Communications and Electrical. Although savings are difficult to identify, this is considered to be a significant operational improvement.
