WHEREAS, America's United Way, our country's premiere organized volunteerism entity, is celebrating the end of its first century of service to America and is looking forward to its second century; and


WHEREAS, there are more than 2,200 United Way organizations across America helping communities meet critical health and human care needs through an ingenious system of local charitable groups; and
