RESOLUTION NUMBER R- 267949

ADOPTED ON MAR 30 1987

WHEREAS, the Committee for the Restoration and Preservation of the Spreckels Outdoor Pipe Organ has recommended that the Spreckels Organ in Balboa Park be restored and refurbished to improve its flexibility by adding additional voices while maintaining its historical authenticity; and

WHEREAS, the Council has authorized by Resolution No. 263986, adopted on September 9, 1985, the creation of a Trust Fund for this purpose; and

WHEREAS, the Spreckels Organ in Balboa Park is unique and is one of the few Exposition instruments still remaining in the United States; and

WHEREAS, the Spreckels Organ was originally constructed by the Austin Organ Company which still retains the original plans for the organ and the necessary parts to refurbish and maintain its historical authenticity; and

WHEREAS, the use of parts from other organ manufacturers would not be compatible with the project and maintaining the organ's historical integrity and authenticity; and

WHEREAS, L. W. Blackington and Associates, Inc. has been associated with the Spreckels Organ since 1955, first as an apprentice to the original curator, and thereafter as the principal craftsman; and

WHEREAS, it appears to the City Council of the City of San Diego that L. W. Blackington and Associates, Inc. and the Austin Organ Company have the necessary experience, capability and credentials to perform this unique task; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That L. W. Blackington and Associates, Inc. and the Austin Organ Company are hereby designated as sole sources for furnishing MATERIALS AND INSTALLATION OF ADDITIONAL VOICES FOR THE SPRECKELS ORGAN IN BALBOA PARK.

2. That the City Manager and the Purchasing Agent are hereby authorized to contract with Blackington and Associates and Austin Organ Company, as necessary, for the phased enhancement of the Spreckels Organ project as funds become available.

3. That the City Auditor and Comptroller is hereby authorized to expend funds currently available not to exceed \$43,000.00 from Trust Fund No. 60255 and to make future expenditures from said Trust Fund as funds become available for the purposes herein set forth.
