WHEREAS, the Civilian Conservation Corps is celebrating the 54th anniversary of the establishment of the Corps, which was active from 1933 to 1942; and

WHEREAS, the Civilian Conservation Corps, established by President Franklin Delano Roosevelt, provided employment for three million youth in our nation and the conservation of our precious natural resources; and

WHEREAS, the Civilian Conservation Corps performed many tasks such as building ranger stations, radio towers, lookout towers, recreation facilities, camp grounds, dams, roads, planting trees and other landscaping in our parks, forests and national monuments; and


