RESOLUTION NUMBER R- 267398

ADOPTED ON MAR 30 1987

WHEREAS, The City of San Diego's Community Block Grant (CDBG) allocation has been reduced approximately fourteen percent (14%) over the past four years; and

WHEREAS, the President's 1988 budget proposal for CDBG calls for a further reduction in CDBG entitlements (\$2.6 billion); and

WHEREAS, a multiyear authorization providing equal and like funding in all years of the authorization would provide the City with a more stable and better planned CDBG program; NOW,  
THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council supports funding the 1988 CDBG Entitlement Program at \$3.4 billion as contained in pending federal legislation and that any CDBG entitlement legislation should contain multiyear authorization at equal and like aforementioned amounts in every year of the authorization.
