

RESOLUTION NUMBER R- 268002

ADOPTED ON MAR 31 1987

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on February 12, 1987, to consider the proposed amendment of the SERRA MESA COMMUNITY PLAN; and

WHEREAS, the proposed amendment affects that portion of the Serra Mesa community located south of Clairemont Mesa Boulevard, between Convoy Street and Mercury Street, known as Graves Tract, Lot 2, by redesignating the community plan's land use from light industrial to general commercial; and

WHEREAS, the Council of The City of San Diego has reviewed the proposed amendment to the SERRA MESA COMMUNITY PLAN and the proposed amendment to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO and approves and recommends adoption of the same; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the amendment of the SERRA MESA COMMUNITY PLAN, a copy of which is on file in the office of the City Clerk as Document No. RR- 268002, be, and the same is hereby approved.

2. That the amendment of the SERRA MESA COMMUNITY PLAN shall become effective upon adoption of an appropriate amendment of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO incorporating said plans at the next scheduled omnibus hearing.
