

RESOLUTION NUMBER R- 268006
ADOPTED ON MAR 31 1987

WHEREAS, MARK II PROPERTIES, by Susan K. Lay, appealed the decision of the Planning Commission in denying Tentative Map No. TM-84-0763 submitted by MARK II PROPERTIES, a California corporation and CRAIG, BULTHUIS & NOTHOMB ENGINEERING for a six-lot subdivision of Lots 32 through 89, Fortune Homes Unit 2, Map No. 9615, Lots 90 through 150, Fortune Homes Unit 3, Map No. 9779, and Lots 153 through 194, Fortune Homes Unit 4, Map No. 9786, located west of 45th Street, south of Imperial Avenue, north of Oceanview Boulevard and east of Horizon Street, in the Southeast San Diego Community Plan area, in the R1-5000 Zone; and

WHEREAS, the matter was set for public hearing on February 24, 1987, and continued to March 10 and 31, 1987, testimony having been heard, evidence having been submitted, and the City Council having fully considered the matter and being fully advised concerning the same; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council adopts and incorporates herein by reference the findings of the Planning Commission in Planning Commission Resolution No. 6737, adopted December 18, 1986, which are supported by the minutes, maps and exhibits, all of which are herein incorporated by reference.

BE IT FURTHER RESOLVED, that the appeal of MARK II PROPERTIES is denied; the decision of the Planning Commission is sustained, and Tentative Map No. TM-84-0763 is hereby denied.
