APPROVING MAP OF CANYON COUNTRY UNIT NO. 12.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Reginald Dale Harvey, Jr., Licensed Land Surveyor, entitled "CANYON COUNTRY UNIT NO. 12 being a subdivision of portions of Parcels 2 and 4 of Parcel Map No. 12882, portions of Parcels 1, 2 and 3 of Parcel Map No. 13065, according to maps thereof on file in the office of the County Recorder of San Diego County, all in the City of San Diego, County of San Diego, State of California, together with a portion of Calle Cristobal, as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

That said Council hereby accepts on behalf of The City of San Diego, the easement(s) with the right of ingress and egress for the construction and maintenance of water facilities, as granted and shown on the map within the subdivision.


That said Council hereby accepts on behalf of The City of San Diego, the building restricted easement(s) over, upon or across Lot 6, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map; together with the easement(s) with the right of ingress and egress for the construction and maintenance of water facilities, and the building restricted easement(s), all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
